As an added feature, you will dock your boats at Koreshan Park for a walk through this historical site, settled originally as a utopian community in the late 1800's. This historic site offers a true "Old Florida" experience for heritage and eco-travelers. The walk includes a nature trail that wanders along the Estero River and through pine flatwoods and scrub oak communities before returning to your kayaks to finish your adventure.

A naturalist guide begins the trip with a brief narration on both the natural and human history of the Everglades and Southwest Florida. Don't expect your average airboat ride down alligator alley; instead imagine an exclusive glide along the pristine waters of Lake Trafford – the environmentally restored headwaters to the historic Everglades. These wetland resources have been targeted for protection and are not available to many. The quality of the lake and the associated watershed affects important wildlife species and offers a sanctuary for migrating birds. Keep an eye out for alligators, birds such as the roseate spoonbill, great white heron, and the golden-footed snowy egret. Lake Trafford accounts for half of all the water flowing to the "River of Grass."
